Dear Mr. Lawton:

This is the final response to your Freedom of Information Act (FOIA) request, dated May 16, 2018, to the U.S. Department of Agriculture's Food Safety and Inspection Service (FSIS). You requested access to a copy of records relating to the Implementation of the Humane Methods of Slaughter Act and the Poultry Products Inspection Act, from January 1, 2018 to May 16, 2018. We received your request in our Office on May 16, 2018.

The FSIS FOIA staff works with subject matter experts across the Agency to locate responsive documents. For this request, we conducted a records search in the Office of Data Integration and Food Protection. FSIS' search began on May 17, 2018. Our search includes responsive records in FSIS' control on that date.

We have located 587 pages that are responsive to your request. After a thorough review, we have determined that portions of pages fall within the exemptions to the FOIA's mandatory disclosure requirements, as explained below. In particular, we have determined that portions of these documents are exempt from disclosure under (b)(4) and (b)(6) of the FOIA, 5 U.S.C. § 552, as amended. Accordingly, this request is granted in part.

Some responsive records constitute confidential commercial or financial information, which is exempt from disclosure under FOIA Exemption 4, 5 U.S.C. § 552(b)(4). Disclosure of this information may cause substantial competitive harm to the person from which this information was obtained. Further, disclosure of this information would impair the government's ability to obtain necessary information in the future.

Portions of the responsive records are exempt from disclosure under FOIA Exemption 6, 5 U.S.C. § 552(b)(6). Exemption 6 protects information that would constitute an unwarranted invasion of an individual's personal privacy. The types of information withheld under Exemption 6 include the names, addresses, or cell phone numbers of employees of Establishments and third parties, including, but not limited to interviewees or customers.

You may appeal this determination within 90 days from the date of this letter. Your appeal should include copies of your original request and this response, as well as a discussion of the reasons supporting your appeal. The envelope should be plainly marked to indicate that it contains a FOIA appeal. If you decide to appeal this determination, please send your appeal to:


